The Rapti Municipality has allocated funds from **Municipal assembly** towards the cost ~~for~~ following project at Rapti Municipality, Chitwan and intends to apply part of the funds to cover eligible payments under the Contract for the Contracts as mentioned below. Bidding is open to all eligible Nepalese Bidders.
2. **Rapti Municipality, Office of Municipal Executive, Chitwan** invites electronic bids from eligible bidders for the construction of **following projects** under National Competitive Bidding procedures. Only eligible bidders with the following key eligibility criteria **as per clause of PPR** should participate in this bidding.

4. Bidding process shall be executed by e-bidding process. Bidders can down load the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the non-refundable fee of NRs. 3000.00 in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at **Rapti Municipality, Office of Municipal Executive, Chitwan at 12 Baisakh 2076 (25 April 2019).**
6. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np on or before **12.00 noon on 19 Baisakh 2076 (2 May 2019)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2.00 PM on 19 Baisakh 2076 (2 May 2019)** at the Rapti Municipality, Office of Municipal Executive, Chitwan. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs **as mentioned below**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
